# Section 2 - Principles to safeguard children from harm

Eventing Ireland is committed to safeguarding children and by working under the guidance of our safeguarding policy, our staff, both volunteers and employed, working with our young people, throughout the organisation, seek to create a safe environment for young people to grow and develop within sport. The following set of principles should be adhered to:

- Importance of childhood The importance of childhood should be understood and valued by everyone involved in sport.
- Needs of the child All children's sport experiences should be guided by what is best for children. This means that adults should have a basic understanding of the emotional, physical and personal needs of young people.
- Integrity in relationships Adults interacting with children in sport are in a position of trust and influence. They should always ensure that children are treated with integrity and respect, and the self-esteem of young people is enhanced.
- Fair Play All children's sport should be conducted in an atmosphere of fair play. The principles of fair play should always be emphasised, and HQ along with Horse Sport Ireland should give clear guidelines regarding acceptable standards of behaviour particularly where children compete alongside and against adults.
- Quality atmosphere & ethos Children's sport should be conducted in a safe, positive and encouraging atmosphere.
- Competition Competition is an essential element of sport and should be encouraged in an age-appropriate manner. A child-centred ethos, within the pony and junior classes, will help to ensure that competition and specialisation are kept in their appropriate place.
- Equality All children should be valued and treated in an equitable and fair manner regardless of ability, age, gender, religion, social and ethnic background or political persuasion.

#### Note:

Access NI is not applicable in ROI so those with just Access NI would have to do Garda Vetting if working in the ROI. This would also apply for someone from the UK or Europe coming over to Ireland, Garda Vetting is legally required.

If a person gets Garda Vetted and there is a NI address on the list of addresses, there is a check for that address with PSNI. Access NI is not legally required, just best practice.
